To All Vendors,

The 2026 Williamsburg Community Farm Show is scheduled for Sunday, August 23rd through Friday, August 28th, 2026.

We invite you to share in our annual celebration! We must have your registration form and payment by July 31, 2026.

Please read and follow these requirements:

1. ***The Williamsburg Farm Show kitchen is reserving the right to be the only vendor selling sausage products. No other vendor may sell any form of sausage.***
2. No other vendor, other than Blair County Dairy Promotion, can sell milk shakes and ice cream products.
3. No vendor can sell cotton candy, snow cones, shaved ice, popcorn, kettle corn, candy apples or coated apples of any kind.
4. Total length and width of space needed must include the trailer hitch and any canopies, windows, or doors that need to be open for service.
5. Any space up to and including 20 feet in length will cost **\$190.00** for food vendors and/or **\$105.00** for non-food vendors for the week. If more than 20 feet is needed, an additional charge of \$10 per foot will be charged.
6. Spaces will be assigned by WCFS staff. Locations are non-negotiable
7. You will have access to two (2) 20-amp standard electrical outlets; any additional needs will be **\$50.00** each hookup. Vendor is responsible for adapting to the outlets provided.
8. Vendor will have access to water, if needed. The vendor must provide hose and tee if needed.
9. All bulky containers such as cardboard boxes, metal cans, etc. must be crushed flat and deposited in the dumpsters – not in the garbage can provided for your customers.

10. Spaces are on a first come, first serve basis as long as space is available. Please note the July 31st deadline for registration.
11. All rental fees must be paid along with the registration. Fees are non-refundable.
12. Vendors may arrive for placement on Friday, August 21st between noon and 8:00pm and Saturday, August 22nd between noon and 8:00pm. All other hours must be communicated and approved by Williamsburg Farm Show.
13. For safety reasons, if you must leave for any reason, you must be back in place by 4:00pm or not occupy the space for that evening. No movement for any reason is permitted while the midway is operating, also for safety reasons.
14. The Williamsburg Community Farm Show Association will not be responsible for damage or losses to the vendor.
15. No weapons or illegal drugs are permitted on Farm Show grounds at any time. Violators will be dealt with severely.
- **16. Food vendors MUST provide a copy of their certificate of liability insurance to the Farm Show representative when returning their application and fee. Food vendors are required to carry \$1,000,000 in liability insurance and name Williamsburg Community Farm Show as the certificate holder. ****
17. All FOOD vendors must be available on Monday, August 24th for inspection by the Department of Agriculture UNLESS you have a valid, permanent inspection. Please show the WCFSA staff the location of your inspection to streamline the Department of Agriculture visit.

Please read these regulations and keep them for future reference.

Get your registration sent in early, after July 31st, we may not be able to place you.
